## Firefly Quantum Chemistry Package License Agreement

Version September 25<sup>th</sup>, 2020

## This Agreement is made between the parties

## 1. The Firefly Project Team

2. The *LICENSEE*, being the individual, research group, institution or organization, or agent who downloads, registers/installs or uses Firefly Quantum Chemistry Package (*SOFTWARE*) comprising the software programs, runtime/shared libraries, installation keys and all the associated documentation, including but not limited to documentation found on the *SOFTWARE* web server at http://classic.chem.msu.su

The *LICENSEE* may obtain a copy of the *SOFTWARE* free of charge by downloading it from the *SOFTWARE* web server at <a href="http://classic.chem.msu.su">http://classic.chem.msu.su</a> and requesting a registration/installation key from *the Firefly Project Team*. The copyright and other intellectual property rights in the *SOFTWARE* are the property of *the Firefly Project Team*. *Firefly Project Team* reserves the right to refuse registration of any *LICENSEE* and issues the installation key for *LICENSEE* at its discretion.

By downloading, requesting registration/installation key, installing or using the *SOFTWARE*, the *LICENSEE* accepts all of the terms and conditions of this Agreement, those being:

- 1. The *SOFTWARE* name(s) are trademarks or registered trademarks of *the Firefly Project Team*. The *SOFTWARE* and related documentation are copyrighted works of authorship. *Firefly Project Team* retains ownership of the *SOFTWARE* name(s), *SOFTWARE* and all subsequent copies of the *SOFTWARE*, regardless of the form in which the copies may exist. This license agreement does not constitute a sale or any form of transfer of ownership of the *SOFTWARE*.
- 2. The *LICENSEE* shall provide valid, accurate and complete registration information as requested by *the Firefly Project Team*.
- 3. The *SOFTWARE* is licensed for use by the *LICENSEE* only. The *LICENSEE* may not rent, lease, sublicense, sell, assign or otherwise transfer the *SOFTWARE* without the prior written consent of *the Firefly Project Team*. However, the *LICENSEE* may create a limited number of copies of *SOFTWARE* as required for *LICENSEE's* operations, but solely for *LICENSEE's* own usage. Should this be the case, these copies will be subject to the same License Agreement as applied to the original *SOFTWARE*. The *LICENSEE* may use any of the Operating System/MPI-specific binaries, which are provided as the part of *SOFTWARE*, within the scope of a single License Agreement.
- 4. The *LICENSEE* will not assign or transfer this Agreement, or any rights or obligations hereunder, without first obtaining the written consent of *the Firefly Project Team*. Upon such assignment, however, the *LICENSEE* shall cease all use of the *SOFTWARE*, and destroy all copies of the *SOFTWARE* immediately.
- 5. The *LICENSEE* agrees that all published work resulting from use of the *SOFTWARE* shall make proper reference to the appropriate program modules, as detailed on the *SOFTWARE* web server at <a href="http://classic.chem.msu.su">http://classic.chem.msu.su</a>
- 6. The *LICENSEE* shall not disclose any part of the *SOFTWARE* to any third party, and shall ensure that the *SOFTWARE* is protected against unauthorized copying.
- 7. Except with prior written permission from *the Firefly Project Team*, or as expressly provided for in this Agreement, the *LICENSEE* may not extract any part of the *SOFTWARE* for incorporation into other

programs, or modify, reverse-engineer, translate, decompile or otherwise misuse the *SOFTWARE*. The *LICENSEE* may not use *SOFTWARE* as the computational server for, or as a fully, partially, or weakly integrated part of any commercial program, package, suite, tool, or interface belonging to either *LICENSEE* or third-party without the prior written consent of *the Firefly Project Team*.

- 8. The *LICENSEE* agrees that its contact details may be held by *the Firefly Project Team* in a secure database, which shall be used for the purpose of *SOFTWARE* license administration only.
- 9. *The Firefly Project Team* shall be under no obligation to provide assistance of any kind in the installation or application of the *SOFTWARE*.
- 10. The *SOFTWARE* is supplied "as is", without warranty, representation or guarantee of any kind, either expressed or implied, including, but not limited to, any implied warranties of quality, merchantability, fitness for a particular purpose or ability to achieve a particular result. The *LICENSEE* assumes the entire risk as to the quality and performance of the *SOFTWARE*. Should the *SOFTWARE* prove defective, the *LICENSEE* assumes the entire cost of all necessary servicing, repair or correction. *Firefly Project Team* does not warrant the correctness of the code or that the *SOFTWARE* will meet the requirements of the *LICENSEE*.
- 11. *Firefly Project Team* periodically makes available upgrades to *SOFTWARE* from the *SOFTWARE* web server at <a href="http://classic.chem.msu.su">http://classic.chem.msu.su</a>. It is the *LICENSEE's* responsibility to keep its copies of the *SOFTWARE* as current as possible.
- 12. Should the *SOFTWARE* prove defective, the *LICENSEE* should immediately notify *Firefly Project Team* about such defects and provide all the material necessary to reproduce and correct them (input, output and other files as requested by *the Firefly Project Team*).
- 13. *Firefly Project Team* makes no representation or warranty that use of the *SOFTWARE* will not result in the innocent infringement of third-party intellectual property rights. *Firefly Project Team* does not accept any responsibility whatsoever for infringement of such rights.
- 14. In no event will *Firefly Project Team* be liable for any damages resulting from loss of data or use, lost profits, loss of anticipated savings, nor for any damages that are an indirect or secondary consequence of any act or omission of *the Firefly Project Team*, whether such damages were reasonably foreseeable or actually foreseen.
- 15. **License termination**. The license is automatically terminated upon the release of the each subsequent major version of the *SOFTWARE* and/or the updated version of the *Firefly Quantum Chemistry Package License Agreement* by *the Firefly Project Team*. *Firefly Project Team* may terminate this license immediately and without warning if *LICENSEE* is found to be in breach of the terms of this Agreement.
- 16. On termination of this Agreement, all copies of the *SOFTWARE* in possession of the *LICENSEE* shall be destroyed immediately.
